### **BWC sending more face coverings to Ohio employers**

At its Aug. 21 meeting, the BWC Board of Directors approved Governor Mike DeWine's request to send another round of face coverings to Ohio employers to reduce the spread of COVID-19. We have shipped 20.6 million masks to 197,000 Ohio employers since late May as part of **Protecting Ohio's Workforce — We've Got You Covered**. In a second round, we will begin this fall sending approximately 23 million masks to employers, who will not be billed for the items. The funding will come from our Division of Safety & Hygiene at no impact to the division's safety services and grant programs. We are working to purchase as many of these masks as possible from manufacturers making them here in Ohio.
