EMERGENCY ACTION PLANS- ARE YOU PREPARED?

Emergencies can happen at any time!

- Be prepared.
- Documenting your plan
- Identify persons responsible for communications.
- Emergencies are not limited to fire, tornado, violence, flood, medical.
- Involve a safety team in planning and developing critical operations activities.
- Practice: Tabletop drills and live drills.

EMERGENCY ACTION PLANS

Steps to Creating a Plan

1. Perform a hazard analysis
2. Create and document your plan
3. Provide training
4. Provide specific PPE
5. Conduct regular exercises
